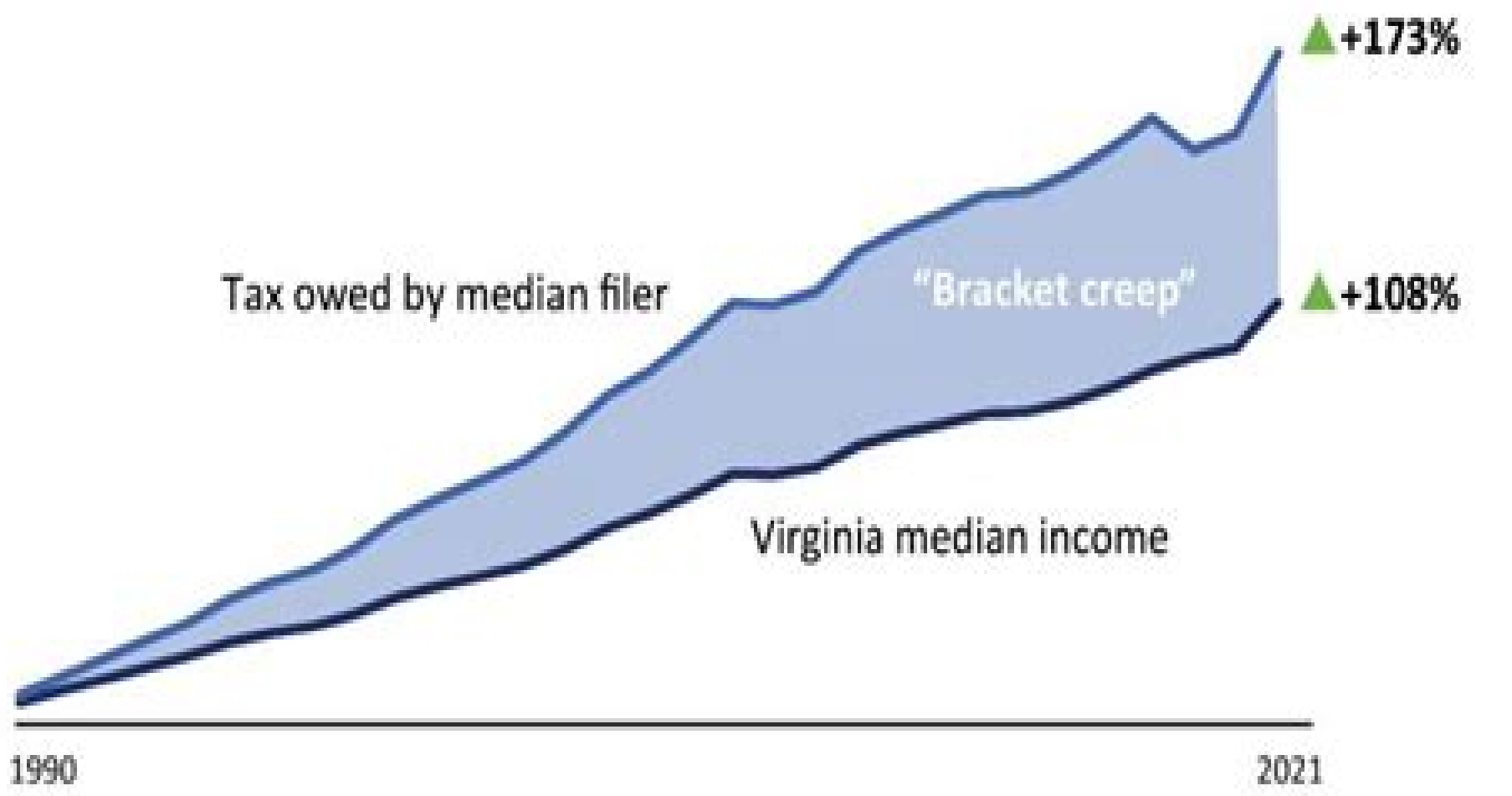


Taxes owed have far outpaced median income, because income brackets have not been changed since 1990
