Das europäische Konzerninsolvenzrecht nach der reformierten EuInsVO Thomas Himmer, 2019-07-08 In der ursprünglichen Fassung der EuInsVO setzte der europäische Gesetzgeber in puncto Konzerninsolvenz aus praktischen und politischen Gründen ganz bewusst auf. Insbesondere in grenzüberschreitenden Konstellationen wurde das Fehlen eines speziellen Rechtsrahmens für Konzerninsolvenzen als enormes Hindernis für eine effiziente Abwicklung empfunden. Mit den seit dem 26.6.2017 geltenden Konzerninsolvenzrechtsvorschriften der reformierten EuInsVO versucht der europäische Gesetzgeber dieser Problematik entgegenzutreten. Thomas Himmer zeigt auf und analysiert, welche Wirkkraft diese neuen europäischen Vorschriften hinsichtlich eines kohärenten und damit funktionsfähigen Konzerninsolvenzrechts entfalten können. Im Fokus stehen dabei insbesondere die Regelungen zum einheitlichen COMI zur allgemeinen Verfahrenskooperation sowie zum Gruppenkoordinationsverfahren.

Im deutschen Rechtsraum ist hier insbesondere das Gesetz zur weiteren Erleichterung der Sanierung von Unternehmen (ESUG) zu nennen. Gerade in Zeiten fortwährender Wirtschaftskrisen, Bankenrettungen und Staatsverschuldungen können selbst rentable Unternehmen schnell häufig sogar unverschuldet in eine wirtschaftliche Schieflage geraten. Durch die nachfolgende Insolvenz und Zerschlagung gehen jährlich ca. 1,7 Millionen Arbeitsplätze in der EU verloren.
