14th Amendment - ✓✓declared that all persons born in the US were citizens, that all citizens were entitled to equal rights and their rights were protected by due process.

Section 1. All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

15th Amendment - ✓✓Section 1. The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of race, color, or previous condition of servitude.

Section 2. The Congress shall have power to enforce this article by appropriate legislation.[1]

The Civil Rights Act of 1964 - ✓✓Outlawed major forms of discrimination against racial, ethnic, national and religious minorities, and women.[2] It ended unequal
