This guidance update is effective for contract year 2019. All enrollments with an effective date on or after January 1, 2019, must be processed in accordance with the revised requirements, including new enrollment forms and notices, as applicable. If disenrollment dates of these updates implement any new requirements consistent with this guidance prior to the required implementation date.

It is expected that organizations will remain compliant with all Medicare Advantage requirements described in this chapter regarding communications, specifically with beneficiaries/enrollees, including the use of the model notices, and the requirements outlined in the Medicare Communications and Marketing Guidelines (4012002).

Organizations are required to provide information to individuals in a comprehensible format (for example, large print, Braille, audio, sign language and pictures) as outlined in Section 504 of the Rehabilitation Act of 1973 and subsequent amendments. It is additionally noted that an equal opportunity in participation in enrollment, policy, practice, rules, and administration with the plan is required to be followed regarding beneficiaries/enrollees.
