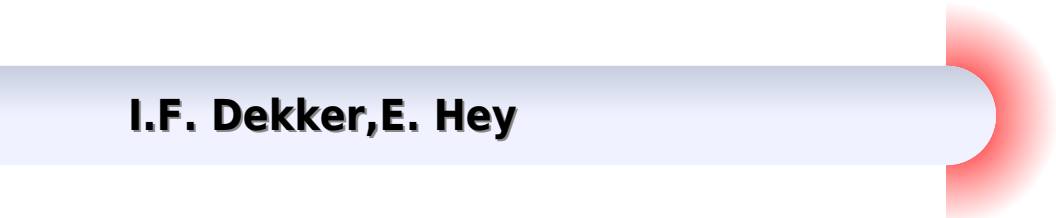

Green,2016-03-03 The persistent objector rule is said to provide states with an escape hatch from the otherwise universal binding force of customary international law. It provides that if a state persistently objects to a newly emerging norm of customary international law during the formation of that norm, then the objecting state is exempt from the norm once it crystallises into law. The conceptual role of the rule may be interpreted as straightforward to preserve the fundamentalist positivist notion that any norm of international law can only bind a state that has consented to be bound by it. In reality

however numerous unanswered questions exist about the way that it works in practice Through focused analysis of state practice this monograph provides a detailed understanding of how the rule emerged and operates how it should be conceptualised and what its implications are for the binding nature of customary international law It argues that the persistent objector rule ultimately has an important role to play in the mixture of consent and consensus that underpins international law Public-Private Partnerships and Responsibility under International Law Lisa Clarke,2014-03-21
