## Doctor Recommendation

To obtain a medical marijuana card, patients must first be diagnosed with a qualifying medical condition by a licensed physician.

Qualifying medical conditions vary from state to state, but may include conditions such as cancer, epilepsy, glaucoma, multiple sclerosis, Crohn's disease, and chronic pain.

The physician must then provide a recommendation for medical marijuana as a treatment option.

Medical marijuana, also known as medical cannabis, is the use of the marijuana plant or its extracts to alleviate symptoms associated with certain medical conditions such as:

- Chronic pain
- Insomnia and drug addiction
- Depression and social anxiety
- Cancer
- Multiple sclerosis
- Epilepsy

Medical marijuana can only be purchased from licensed dispensaries in states where it is legal.

They also offer a variety of different strains of marijuana, as well as other cannabis products such as edibles, tinctures, and concentrates.

According to a survey by the National Conference of State Legislatures as of September 2019, medical marijuana is legal in 36 states plus Washington D.C.
