Definition of Condition & Warranty

Condition :

The Sale of Goods Act 1930 provides the definition for a Condition as – *“A condition is a stipulation essential to the main purpose of the contract, the breach of which gives rise to a right to treat the contract as repudiated”*

Warranty :

“A warranty is a stipulation collateral to the main purpose of the contract, the breach of which gives rise to a claim for damages but not to a right to reject the goods and treat the contract as repudiated”.
